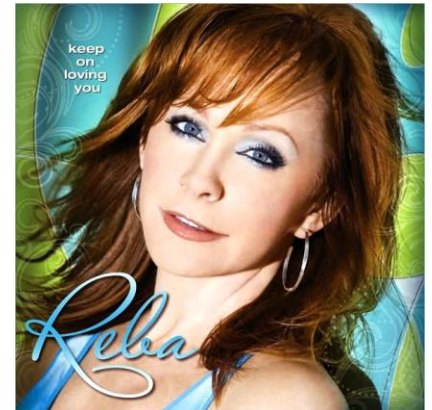

Reba McEntire Concert at the Ohio State Fair

Optional trip to Scioto Downs Casino
Thursday, July 26, 2018

Please eat lunch prior to departure or feel free to bring lunch along on the bus

- 11:00 am - Noon Approximate pickup time depending upon your pickup location. Pickups will be in either Coldwater or Celina, and St. Marys and Wapakoneta. Exact pickup times and locations will be determined approximately 30 days prior to trip departure
- 1:30 pm Approximate time to arrive at the Fair to drop passengers that want to spend the entire time at the fair
- 2:00 pm Approximate time to arrive at Scioto Downs Casino
- 6:00 pm Pick up passengers at Scioto Downs and bring them to the fair. All passengers will be at the fair at this time.
- 7:00 pm Reba McEntire concert begins. One of the most successful female recording artists in history, Reba has sold over 56 million albums worldwide and is a member of the Country Music Hall of Fame and Hollywood Bowl Hall of Fame. She has won 15 American Music Awards; 13 ACM Awards; 9 People's Choice Awards; 7 CMA Awards; 2 GRAMMY Awards; an ACM Career Achievement Honor; and is one of only four entertainers in history to receive the National Artistic Achievement Award from the U.S. Congress. Reba's reign of #1 hits spans four decades and she is recognized as the biggest female hit maker in Country music history.
