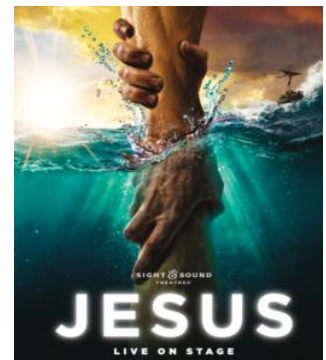
Tuesday, November 13th
