November 28-29, 2018

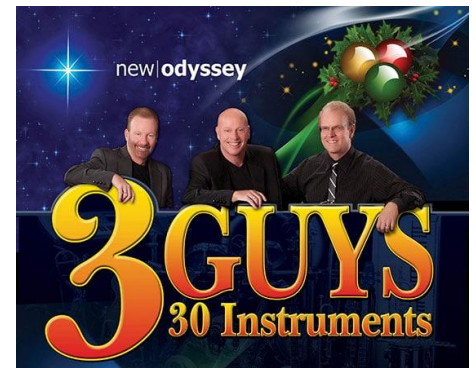
Wednesday, November 28
