- 8:00- 9:00 am Approximate departure time depending upon your pick up location. Pickups will be in either Coldwater or Celina, St. Marys, and Wapak. Exact pickup times and locations will be determined approximately 30 days prior to trip departure.
- 11:00 am Approximate time to drop off passengers wishing to go to the Ohio State Fair
- 11:20 am Approximate time to drop off passengers that want to go to Scioto Downs Casino
- 1:00 pm Lunch on your own at the fair or at the casino
