- 6:30 -7:30 am Approximate departure time depending upon your pickup location. Pickups will be in Coldwater or Celina, St. Marys, Wapak, and Lima. Exact pickup times and locations will be determined approximately 30 days prior to trip departure

It also has the very best views of the Empire State Building. Your tour continues downtown passing Greenwich Village, SOHO, Little Italy, Chinatown to Wall Street, the World Trade Center and 911 memorial and more.

The Statue of Liberty Enlightening the World" was a gift of friendship from the people of France to the United States and is recognized as a universal symbol of freedom and democracy. The Statue of Liberty was dedicated on October 28, 1886. It was designated as a National Monument in

1924. Employees of the National Park Service have been caring for the colossal copper statue since 1933. Ferries provide transportation to both Ellis Island and Liberty Island (site of the Statue of Liberty). One ferry ticket provides access to both islands. Statue Cruises is the official ferry service provider.
