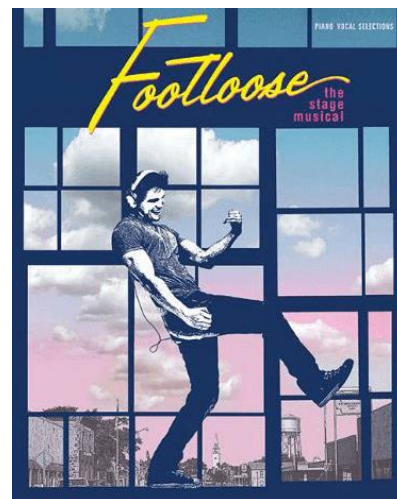
Wednesday, May 13th

- 8:30 - 9:30 am Approximate time to depart depending upon pickup location. Pickups will be in either Celina or Coldwater, St Marys, Wapak, and Sidney. Exact pickup times and locations will be determined approximately 30 days prior to trip departure.
- 11:35 am Arrive at Great American Ball park. Lunch on your own at the ball park. **You can bring your own food and drinks (small soft sided coolers, no glass or cans) into the ball park**
- 12:35 pm Enjoy a reserved infield box seats (in the shade) for the afternoon game against the Florida Marlins
- 4:15 pm Approximate time to depart the ballpark.
- 5:15 pm Check into Belterra Casino. You will receive \$10 casino cash and dinner & breakfast buffet vouchers. Evening is at your leisure to enjoy the casino.
