

Holidays at Oglebay, Hershey and Lancaster PA

Wednesday - Saturday, November 17- 20, 2021

Wednesday, November 17th

- 7:30 – 8:30 am Approximate time to depart depending upon your pickup location. Pickups will be in Coldwater or Celina, St. Marys and Wapak . Exact pickup times and locations will be determined approximately 30 days prior to trip departure
- 11:30 am Lunch on your own in Cambridge OH .
- 12:30 pm Tour of the Dickens Village. Wheeling Ave in downtown Cambridge is charmingly transformed into a Dickens Victorian Village each holiday season. See over 92 scenes of 180 lifelike figures representing classic scenes from the Victorian era. The Dickens Victorian Village scenes are comprised of life sized and hand-made mannequins wearing real vintage clothing. The faces for each character are individually sculpted and painted by local artists. The displays include engaging depictions of classic Dickens-era scenes and figures such as Bob Cratchit and Tiny Tim and more.
- 3:00 pm Depart Cambridge for Oglebay Park in Wheeling WV.
- 4:00 pm Arrive a Oglebay Park for some shopping time, dinner, holiday musical show and guided tour of the famous light display. The Festival of Lights has grown into one of the nation's largest holiday light shows, attracting more than 1 million visitors each year. The light show features more than 1 million LED lights incorporated in nearly 90 displays and trees that cover 300-plus acres over a six-mile drive through Oglebay Park.

- 1:15 pm Depart for Sight and Sound Theater in Lancaster PA
- 2:15 pm Arrive at Sight and Sound Theater for "Queen Esther" performance. Show begins at 3:00 pm. Set in the opulent yet perilous Persian Empire, *QUEEN ESTHER* is a captivating tale of beauty and bravery. Esther's ordinary life changed



forever when she was taken through the palace doors, entering a new world of royalty and risk. With a crown on her head and a secret in her heart, can she find the courage to trust in God's plan and believe that she was made for such a time as this?

- 9:00 am Visit Hershey Story Museum and participate in their Chocolate Lab experience. For well over 100 years, the word "Hershey" has been synonymous with the Great American Chocolate Bar. But before the world fell in love with his chocolate, Milton S. Hershey was a struggling entrepreneur determined to make a difference. Museum attractions present his legacy. The Chocolate Lab offers 45-minute, daily classes for guests to try their hand at chocolate pouring and decorating, and of course when it's over, taste their delicious take-home chocolate creations.
