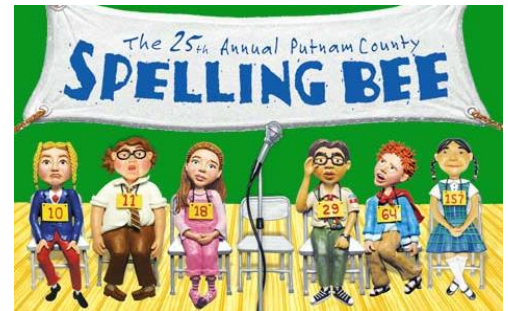
Wednesday, August 17th
