**THERE WILL NOT BE SOCIAL DISTANCING ON THE BUS – MASKS MAY BE REQUIRED**

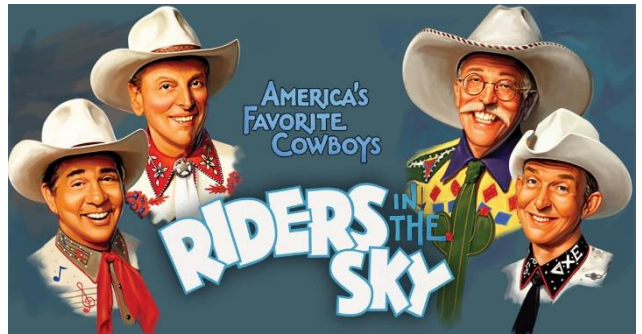
### Thursday, May 4, 2023
