- 8:30 - 9:30 am Approximate time to depart depending upon pickup location. Pickups will be in either Celina or Coldwater, St Marys, Wapak, and Sidney. Exact pickup times and locations will be determined approximately 30 days prior to trip departure.
- 11:35 am Arrive at Great American Ball park. Infield Box Seat in the Shade! Lunch on your own at the ball park. **You can bring your own food and drinks (small soft sided coolers, no glass or cans) into the ball park. Ball park vendors will only accept credit / debit cards – no cash. No backpacks**
- 12:35 pm Enjoy a reserved infield box seats (in the shade) for the afternoon game against the Arizona Diamondbacks
