- 11:35 am Arrive at Great American Ball park. Infield Box Seat in the Shade! Lunch on your own at the ball park. **You can bring your own food and drinks (small soft sided coolers, no glass or cans) into the ball park. Ball park vendors will only accept credit / debit cards – no cash. No backpacks**

- 4:15 pm Approximate time to depart the ballpark for Belterra Casino

- Balance due 30 days prior to departure. Additional trip information and billing will be sent at that time.
