- 7:30 – 8:30 am Approximate time to depart depending upon your pickup location. Pickups will be in Lima, St Marys, Wapak and either Celina or Coldwater. Exact pickup times and locations will be determined 30 days prior to trip departure.
- 11:30 am Arrive at Firekeepers Casino for gaming and lunch on your own. If you already have a Firekeepers Players Card, please bring it with you. Incentives will be determined closer to the trip
- 3:30 pm Depart Firekeepers Casino
- 5:15 pm Check in at Soaring Eagle Casino & Hotel (989) 775-5777. You will receive \$30 in casino cash and a \$20 dining card that you can use at any of their eating options anytime during your stay. Rest of evening free.

- 10:00 am Depart Soaring Eagle casino for Frankenmuth
- 11:15 am Arrive at Zehnders in Frankenmuth for lunch and Three Men & A Tenor matinee holiday show. - Balance due 30 days prior to departure. Additional trip information and billing will be sent at that time.
- **Cancellation Policy - Deposit fully refundable up to 30 days prior to trip departure; 30-14 days prior to departure– 50% of your trip cost is non-refundable; 14 days prior to departure – 100% of trip cost is non-refundable. If replacement is found, you will be refunded all your money except for a \$25.00 per person cancellation fee.**
